# PRIVACY POLICY Last Updated: April 20, 2022

This privacy policy ("**Policy**") describes how Grandslam Performance Associates, LLC ("**Serve2Perform**") collects, uses, protects and shares personal information of users of this website, www.iserve2perform.com (the "**Site**"). Serve2Perform is an Arkansas limited liability company that exists to provide users of the Site to provide experiential learning for users to cultivate talent and build human capacity ("**Services**").

## WHAT WE COLLECT & HOW WE USE IT

We respect your information and our goal is to collect as little user information as possible while still providing a quality service to you. We receive and store information about you in a range of ways.

**Information You Give Us.** We collect your name, postal address, credit card information, email address, email settings, username, password, telephone number, birthdate, photographic image, profile information as well as other information you directly give us on our Site, like purchase history from Serve2Perform, event attendance on our Site and in person so that we can provide a customized and personal user experience for you and so that we can provide services and events that you have requested to you. This information allows us to update our services and learn how we can better equip the Site to serve you. **Cookies.** We may log information using "cookies." Cookies are small data files stored on your hard drive by a website. We may use both session Cookies (which expire once you close your web browser) and persistent Cookies (which stay on your computer until you delete them) to provide you with a more personal and interactive experience on our Site. This type of information is collected to make

the Site more useful to you and to tailor the experience with us to meet your special interests and needs.

We may also use the information we collect to more effectively respond to your service needs. Any data or information we collect will never be shared except under the circumstances discussed in this Policy.
